### **Personal Information that SPIRITUALPLR.COM May Collect Online**

Spiritualplr.com collects the following types of personal information: names, postal and e-mail addresses, and phone numbers only when website visitors subscribe to our mailing list, request a free eBook or report or makes a purchase directly from Spiritualplr.com.

We do not obtain personally identifying information about you when you visit our website, unless you choose to provide such information to us.

### **Information Sharing**

### **Mailing List Removal/Opt-Out**

## **Children**

### **Cookies**

Cookies are small files that web servers place on a user's hard drive. They can serve several functions:
